

SCAQMD ACTIONS WILL GET MORE DOLLARS FROM BLUE COLLARS



I can't for the life of me figure out what beef the South Coast Air Quality Management District (SCAQMD) has against local businesses and blue collar pocketbooks. It's like the Hatfields vs the McCoys vs the McCoys. At every turn of the stone the District is taking potshots at industries moseying down the road minding their businesses by the codes the District established. Then the agency changes those rules.

The recent threat by President Trump to close the borders got the attention of all 40 million residents of the state as that closure would have temporarily increased the cost of their guacamole! Most of the residents are unaware of the efforts of the SCAQMD that would permanently, not just temporarily, increase the costs of their fuels statewide and hit the blue collar workers pocketbooks for the foreseeable future as the SCAQMD has proposed an option that would ban a critical refinery processing technology currently used at two southern California refineries to manufacture cleaner burning gasoline that the District previously supported – MHF.

Via Proposed Rule 1410 the agency is planning to develop a regulation by May 2019 that would better mitigate the risk from, or possibly phase out, the use of MHF. MHF is a modified form of HF – hydrofluoric acid. This modified formula is the latest advance in catalyst technology that enhances worker and community safety. In fact, the Bureau of Labor Statistics (BLS) shows the downstream-energyrefining-sector has reduced injuries for over 20 years. The

Bureau of Labor Statistics charts show that the petroleum-refining sector of health and safety is one of the safest industries to work in. According to the BLS, it's safer to work in a refinery than an office building!

HF or MHF technology is currently in use at 50 U.S. refineries. Banning the District previously supported technology in California would negatively affect all 40 million residents economically and environmentally. According to the California Energy Commission (CEC), this would result in permanent spikes in fuel costs and higher GHG emissions. The unintended consequences of importing aviation, diesel, and gasoline fuels from other countries or states with less stringent environmental regulations seems counterproductive in that the SCAQMD's main objective is to preserve the air quality of the region and this new proposal would do quite the opposite.

In addition to the fifty U.S. refineries currently using HF or MHF in their alkylation units:

- HF has been used in manufacturing since the 1700's which is over 250 years.
- HF alkylation has been used in California refineries since 1966.
- Today, the refining industry makes up less than two percent of HF use.
- Many major industries in southern California and across the country use HF to create common consumer products like computers, televisions, cell phones, medicines, refrigerants, and countless other items we use every day.

California imports over 57% of its oil needed to support its infrastructure. The current price California pays to foreign countries for imported oil is 60 million dollars a day. You can say, bye-bye to that number in the rear-view mirror if SCAQMD makes the changes to MHF technology it is proposing which will effectively shut down the two major refineries in Southern California while they retool or possibly decide the expense is beyond recapitulation and elect to close down permanently.

What is extremely important here is there are inadequate storage facilities to manage importing fuels for aviation, trucks, and cars at the increased level a phase-out would require.

If the SCAQMD's actions result in the shutdown of the PBF and Valero refineries, the economic impact would be devastating to the State. Banning MHF at the two refineries would:

- Eliminate 30% of the jet fuel supply for the Los Angeles International Airport. •
- Eliminate more than 75% of the marine diesel fuel for ships at the Ports of Los Angeles and Long Beach. •
- Eliminate 30% of Southern California's gasoline supply. •
- Raise the costs of thousands of products made from petroleum materials used by every infrastructure in Southern California.

Not only does this affect California but it sets up the world for more emissions, and greater costs across the board for blue collar workers. Sulfuric acid process, the alternative to MHF, brings increased emissions and with it, acid trucks driving through communities and across our highways. Good luck getting CEQA to permit increased emissions and any uptick in the truck traffic they've spent decades trying to eliminate.

Californians already pay almost \$1.00 more per gallon of fuel than the rest of the country due to a) the state sales tax per gallon which are some of the highest in the country; b) refinery reformatting costs per gallon; c) cap and trade program compliance costs per gallon; d) low-carbon fuel standard program compliance costs per gallon; and e) renewable fuels standard program compliance costs per gallon.

If the SCAQMD wanted to win its ongoing feud with southern California's businesses and blue-collar wallets, this would undoubtedly do it. The South Coast Air Quality Management District needs to look at the entirety of their proposal and the financial impact it would have on all residents of the state. Upon review they will find the current way is the safest, most efficient and cost effective alternative available. If it ain't broke...

CALTRANS MUST SELL BACK CONDEMNED HOMES AT Original Purchase Price Regulatory Takings May Result

More than 50 years ago, Caltrans purchased roughly 500 homes under threat of eminent domain within the planned rightof-way for the anticipated construction of the I-710 freeway (linking Monterey Park to Pasadena). As we reported a number of years ago, Caltrans finally decided to sell those homes once it became clear the alignment would not be utilized. We haven't heard much on how that sales process was going, but the Pasadena Star reported recently that it has been the subject of litigation, which has now reached an outcome.

In Steve Scauzillo's April San Gabriel Valley Tribune article, Renters of Caltrans-owned homes in South Pasadena get to buy them \$970,000 below market, several current tenants will be able to purchase their properties back from Caltrans for the same price Caltrans paid in 1963 — which range from the mid-\$20,000's to mid-\$30,000's. Caltrans had attempted to sell the homes back at the same price, but adjusted for inflation, which brought the prices up to several hundred thousand dollars (which was still dramatically below their fair market value of over \$1 million). The court disagreed with Caltrans' inflation adjustment, concluding that the homes should be offered back at the original acquisition price – no more, no less:

"The Caltrans policy of adjusting the original acquisition price adjusted for inflation to determine the affordable sales price for the petitioners' homes is an underground regulation and is therefore nullified."

Beckloff ruled that Caltrans came up with the idea of upping the sales price — sometimes six or seven times the acquisition price — on its own. In other words, officials made it up. "Caltrans cannot use its pricing methodology," Beckloff wrote, saying the bureaucracy was acting in a "type of 'quasi-legislating' power …"

Caltrans tried to argue that selling any state-owned properties for less than fair market value would be cheating the taxpayers. In its court briefs, Caltrans said it was "obligated and authorized," and in fact "mandated by law" to "adjust the original acquisition prices for inflation." The court explained that Caltrans has no authority to vary from what is known as

the "Roberti Law," a complex set of regulations that requires Caltrans to offer the homes to tenants living there for a certain period of time and at an affordable price who are low- and moderate-income. Of the 460 surplus properties, tenants at about 120 of them qualified for the affordable price program. Caltrans didn't walk away empty-handed. The court kept intact covenants that will remain as liens on the property during a transfer of ownership. The tenant does not realize the full equity, only the appreciation from the sales price from the purchase to the next sale. In other words, upon a later sale, about \$900,000 in equity would go to a state agency charged with building affordable housing, called the California Housing Finance Agency.



The 710-freeway example — with Caltrans' ownership dating now over 50 years — is quite the story. After the backlash from the famous eminent domain Kelo decision and the enactment of Proposition 90 in California, the results today would likely have played out differently. Under California Code of Civil Procedure section 1245.245, if a public entity does not put condemned property to public use within 10 years of the adoption of the resolution of necessity (and does not adopt a new resolution), the public entity is required to offer the property back to the original owner at the present market value, unless it is a single family residence, in which case it is to be offered back at the price paid by the agency, adjusted for inflation, if the original owner meets low or moderate income requirements. If the original owner cannot be found, the agency is required to sell the property as surplus.




